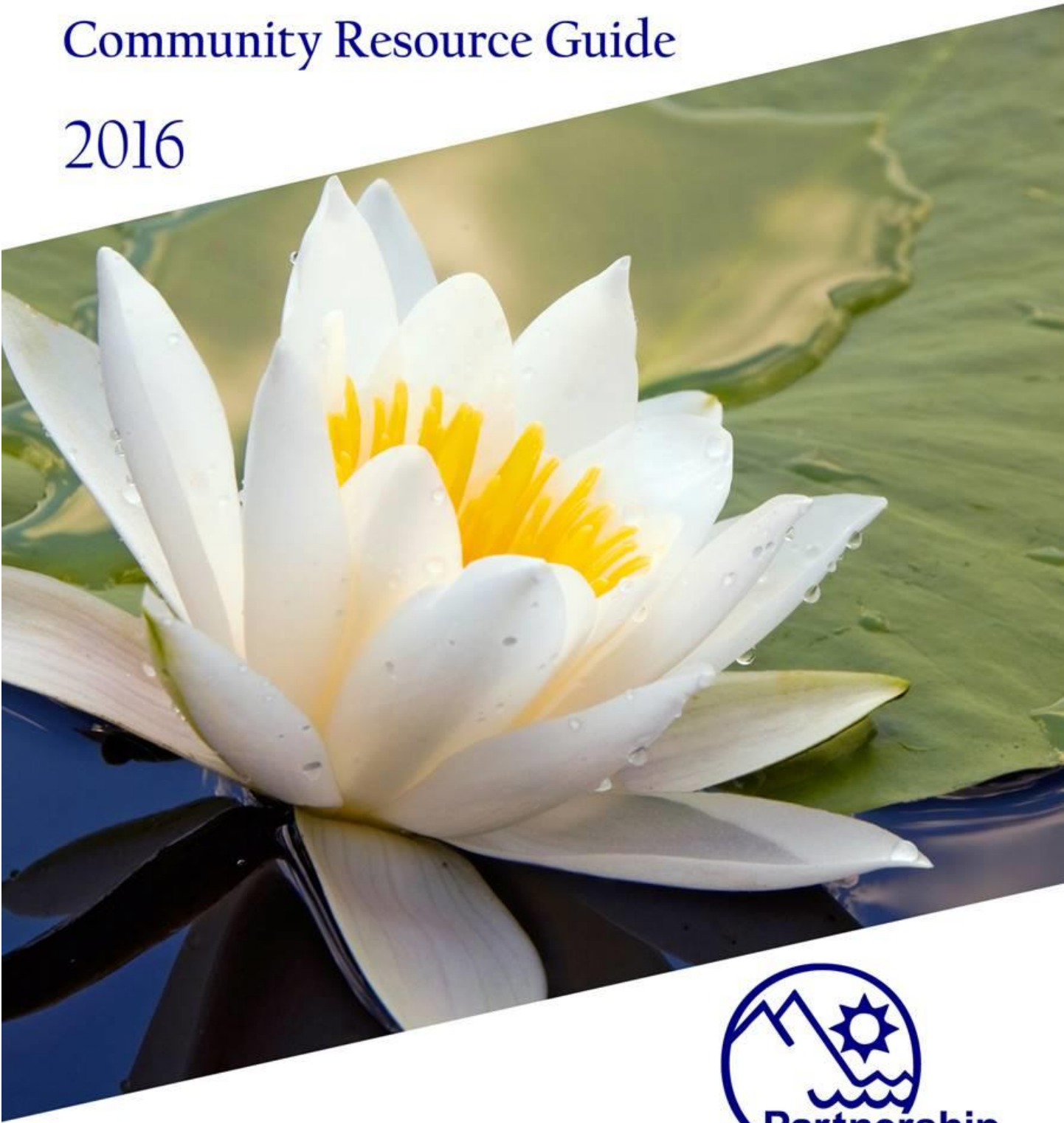

# **Counseling Resources**

---

## **Guide to Counseling Definitions**

**Psychiatrists (M.D.)** are medical doctors with specialized training in the diagnosis and treatment of emotional problems. Psychiatrists are the only mental health professionals who can prescribe medication. Other counselors may work with a psychiatrist if their patients need medication. Some psychiatrists have taken specialized training in marriage and family therapy techniques, but not all psychiatrists are trained to do this.

**Psychologists (Ph.D.)** complete four to five years of professional study in the behavioral sciences. They receive a Ph.D. and can use the title of “Dr.” Before they can apply for licensure, they must have two years of supervised professional internship. Psychologists have special training in administering and interpreting a variety of personality and aptitude tests. Some psychologists have been trained in marriage and family therapy techniques, but this training is not automatic for psychologists.

**Marriage and Family Therapists (L.M.F.T.)** concentrate on helping individuals, couples, and families to resolve interrelationship issues. To qualify for licensing, they must have a Master’s degree in marriage counseling or the behavioral sciences, and two years of supervised experience. Their training emphasizes marriage and family relationships.

**Clinical Social Workers (L.C.S.W.)** have a Master’s degree in social work and complete two years supervised experience in individual, couples and family therapy before they are licensed to practice. Social workers who have this additional experience are Licensed Clinical Social Workers, or L.C.S.W. The training received by social workers emphasizes the social needs and interactions of people.

**Drug and Alcohol Counselors (L.D.A.C.)** are certified to provide evaluations and counseling in the areas of drug and alcohol issues. They may run DUI schools and may or may not be licensed in other counseling areas.
